 Social Security card or ITIN for each family member

 W-2 forms for all jobs held and all 1099 or 1098 forms


 Child care provider information

 A voided check to direct deposit your refund

 Last year's tax return (if you have it)


 Health insurance statement form 1095-A, 1095-B or 1095-C (if you have it)
